## **CHAPTER W-13.2 REG 2**

### *The Wildlife Habitat Protection Act*

#### **Title**

- 1** These regulations may be cited as *The Treaty Land Entitlement Withdrawal Regulations*.

#### **Interpretation**

- 2** In these regulations:

- (a) “**Act**” means *The Wildlife Habitat Protection Act*;
- (b) “**Schedule**” means the Schedule to the Act.

#### **Wildlife habitat lands withdrawn**

- 3** For the purposes of the Framework Agreement within the meaning of subsection 9(2) of the Act, the lands listed in the Appendix:

- (a) are withdrawn from the Schedule mentioned in subsection 3(1) of the Act; and
- (b) cease to be designated as wildlife habitat lands pursuant to subsection 3(1.1) of the Act.
