1. člen

RULES

on the uniform application form for plant consignments, plant products and regulated articles, forest reproductive material or seeds and propagating material of agricultural plants for import inspection

(unofficial consolidated version No. 1)

Article 1

Ta pravilnik določa enotni obrazec prijave za inšpekcijski pregled pošiljke rastlin, rastlinskih proizvodov in nadzorovanih predmetov, gozdnega reprodukcijskega materiala oziroma semenskega materiala kmetijskih rastlin, ki mora biti pred uvozom inšpekcijsko pregledana (v nadaljnjem besedilu: enotni obrazec prijave).

Enotni obrazec prijave je dostopen na Fitosanitarni upravi Republike Slovenije (v nadaljnjem besedilu: Uprava) in na spletni strani Uprave (www.furs.si).

2. člen

Izrazi, uporabljeni v tem pravilniku, pomenijo:

1. rastline, rastlinski proizvodi in nadzorovani predmeti so rastline, rastlinski proizvodi in nadzorovani predmeti s seznama V.B v skladu s predpisi, ki urejajo zdravstveno varstvo rastlin;
2. gozdni reprodukcijski material so semenski material, deli rastlin in sadilni material drevesnih vrst in umetnih križancev v skladu s predpisi, ki urejajo gozdni reprodukcijski material;
3. semenski material kmetijskih rastlin so seme, cele rastline ali deli rastlin vrst kmetijskih rastlin v skladu s predpisi, ki urejajo semenski material kmetijskih rastlin;
4. semenski material kmetijskih rastlin so tudi deli rastlin in sadilni material drevesnih vrst in umetnih križancev iz 2. točke tega člena, če jih pri uvozu spremlja pisna izjava dobavitelja, da »niso za uporabo v gozdarstvu« oziroma so kot taki jasno označeni.

3. člen

Enotni obrazec prijave se vloži pri pristojnem fitosanitarnem inšpektorju v dveh izvodih.

4. člen

Na podlagi enotnega obrazca prijave se opravi skupni

These Rules regulate the uniform application form for inspection of consignments of plants, plant products and regulated articles, forest reproductive material or seeds and propagating material of agricultural plants that should be inspected prior to import (hereinafter referred to as: uniform application form).

The uniform application form is available from the Phytosanitary Administration of the Republic of Slovenia (hereinafter referred to as: Administration) and on its website (www.furs.si).

Article 2

For the purpose of these Rules the following definitions shall apply:

1. plants, plant products and regulated articles mean plants, plant products and regulated articles on list V.B pursuant to the regulations governing plant health;
2. forest reproductive material means seed material, parts of plants and planting material of tree species and artificial hybrids pursuant to the regulations governing forest reproductive material;
3. agricultural seeds and propagating material mean seeds, whole plants or parts of plants of agricultural plant species pursuant to the regulations governing agricultural seeds and propagating material;
4. seeds and propagating material of agricultural plants also mean parts of plants and planting material of tree species and artificial hybrids referred to in point 2 of this Article, if they are accompanied by a written statement of the supplier upon import that they are 'not for use in forestry' or are clearly marked as such.

Article 3

The uniform application form shall be lodged in duplicate with the responsible phytosanitary inspector.

Article 4

On the basis of the uniform application form, the joint inspection

inšpekcijski pregled in izda ena odločba, s katero se dovoli ali prepove uvoz pošiljke rastlin, rastlinskih proizvodov in nadzorovanih predmetov, gozdnega reprodukcijskega materiala oziroma semenskega materiala kmetijskih rastlin.

Odločba iz prejšnjega odstavka se izda v obliki uradnega zaznamka na prijavi.

5. člen

Ta pravilnik začne veljati naslednji dan po objavi v Uradnem listu Republike Slovenije.

Priloga: (črtana)

shall be carried out and one decision shall be issued to authorise or prohibit the import of the consignment of plants, plant products and regulated articles, forest reproductive material or seeds and propagating material of agricultural plants.

Decision referred to in the preceding paragraph shall be issued in the form of an official endorsement on the application.

Article 5

These Rules shall enter into force on the day following their publication in the Official Gazette of the Republic of Slovenia.
