FOREST CONSERVATION ORDINANCE

THE Order under section 3A of the Forest Conservation Ordinance (Chapter 451), as amended by Act, No. 13 of 1966, Act, No. 56 of 1979, Act, No. 13 of 1982, Act, No. 84 of 1988, Act, No. 23 of 1995 and Act, No. 65 of 2009.
