AN ACT to amend certain existing Acts preparatory to their inclusion in the Revised Edition of the Laws of Saint Vincent and the Grenadines.

[23rd July, 1991]

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly of Saint Vincent and the Grenadines, and by the authority of the same as follows:—

1. This Act may be cited as the Miscellaneous Amendments Act, 1991. Short title
2. The Excise Act is amended, in section 11 (2), by the deletion of the words "who has been convicted of felony: if a distiller is convicted of felony" and by the substitution of the words "who has been convicted of an offence punishable with imprisonment for two years or more: if a distiller is convicted of an offence punishable with imprisonment for two years or more". Amendment of

3. The Exchange Control Act, 1951, is amended as follows — Amendment of
Act 28 of 1951
 - (a) by the deletion of the words "sterling or" wherever they appear, and without prejudice to the generality of the foregoing they shall be deleted in section 2 (4), 3 (4), 6 (3) and (4), 26 (1) and (2), 29 (1) and 36 (2); and

(b) by the repeal of the First Schedule and by the substitution of the following –

“FIRST SCHEDULE

Anguilla
Antigua and Barbuda
Dominica
Grenada
Montserrat
Saint Christopher and Nevis
Saint Lucia
Saint Vincent and the Grenadines”

- Amendment of Act 5 of 1982
4. The Fiscal Incentives Act, 1982 is amended in paragraph 2 of Part II of Schedule II, by the deletion of subsection (b) (ii) and the substitution of the following –
- (ii) “E” represents the proceeds of export sales (ex-factory) of the output of an Enterprise during its year of income;
 - (iii) “S” represents the proceeds of all sales (ex-factory) of the output of an Enterprise during its year of income.”
- Amendment of Act 16 of 1987
5. The Wildlife Protection Act, 1987 is amended in section 15
- (a) by deleting from subsection (1) the words “subsection (3) and”;
 - (b) by deleting subsection (3).
- Amendment of Act 20 of 1987
6. The Law Revision Act 1987 is amended in the Third Schedule by the deletion of the following items –
- “Royal Proclamation of King George dated the 7th October, 1763.
The West Indies Act 1967 (U.K. 1967 C.4)
The West Indies (Appointed Days) Order (U.K. 1967 No. 222)”
- and by the substitution therefor of the following –
- “Air Transport (Licensing of Air Services) Regulations, 1952 (S.R.O. 94 of 1952)
Civil Aviation (Investigation of Accidents) Regulations, 1958 (S.R.O. 29 of 1958)

Air Transport (Landing and Parking Charges) Regulations, 1961 (S.R.O. 24 of 1961)

E.T. Joshua Airport (Designation as Customs Airport) Order, 1961 (S.R.O. 26 of 1961)

Air Navigation (Fees) Regulations 1980 (S.R.O. 33 of 1980)"

7. The Saint Vincent and the Grenadines Port Authority Act, 1987, is amended as follows –

Amendment of Act 26 of 1987

- (a) in section 5 (7), by the addition, immediately after the words "or otherwise shall", of the words "be notified in the Gazette"; and
- (b) in section 88, by the deletion of the word "may" appearing immediately before the word "contact" and by the substitution of the words "or any".

8. The Radio Communications Services Act, 1988, is amended as follows –

Amendment of Act 19 of 1988

- (a) by the insertion next after section 8 and immediately before the words "satisfied that the application" the following –
"Technical parameters 9. If the telecommunication officer is"; and
- (b) in section 36 (2) by the insertion immediately after the words "that person shall" of the words "(a) be a member of –".

9. The Application of English Law Act, 1989, is amended by the deletion from Part I of the Schedule of the following –

Amendment of Act 36 of 1989

- (a) "57 and 58 Vict. c.60 Merchant Shipping Act, 1894, s. 510–569"; and
- (b) "4 and 5 Eliz. 2 c.74 Copyright Act, 1956, s. 1-22, 31, 33, 36-41, 43, 45-51, First-Third Schedules and Sixth-Eighth Schedules (as amended by the Performers' Protection Acts, 1958 and 1963, and the Films Act, 1960, and as modified by U.K.S.I. 1967 No. 974)".

Incorporation in
the Revised
Edition

10. The amendments effected by sections 2 to 9 shall be incorporated in the Revised Edition of the Laws of Saint Vincent and the Grenadines referred to in the Law Revision Act, 1987.
