

THE CROWN LANDS ACT

An Act to proclaim certain areas of land in Swaziland to be Crown lands.

Short title.

1. This Act may be cited as the Crown Lands Act. No. 9 of 1949

Land to be grown land.

2. The areas of land in Swaziland and described in the second column of the Schedule to this Act shall, from the respective dates set out in the third column thereof, be Crown lands, and shall be registered and known as numbered in the said Schedule:

Provided that the proclamation of the said areas as Crown lands shall not affect any concession, lease, servitude or other right subsisting in respect of the said areas at the date set out in the third column and not vested in the Crown.
