**ON THE STRUCTURAL REORGANISATION OF KOLHOZES, SOVHOZES
AND OTHER AGRICULTURAL ENTERPRISES**

With a view to create necessary conditions for development of new organisational forms of farming and increase of the effectiveness of the agricultural production, the Government of the Republic of Tajikistan **resolves**:

1. To admit reasonable the establishment of associations of tenants, co-operatives, dehkan farms, other organisational forms of farming, corresponding to the requirements of the market economy on the basis of the low-profitable and unprofitable kolhozes, sovhozes and other agricultural organisations and enterprises.

2. To transform the sovhozes, which are providing the profitable level of conduction, into kolhozes.

3. To order the Ministry of Agriculture of the Republic of Tajikistan, the Republican association "Tajikboghounyod ", the Committee for the food and processing industries under the Government of the Republic of Tajikistan, other ministries, departments and organisations, whose structural systems are including sovhozes and other agricultural enterprises, and also to order the hukumats of regions, districts and towns and to recommend to the Councils of kolhozes of Tajikistan:

a) to analyse the financial-economic activities of agricultural subdivisions during the whole 1995 and to implement the necessary organisational work on the execution of the items 1-2 or the current decree;

b) to create proper co-operatives, unions, associations and other organisational structures on the basis of machining parks, repairing shops, internal-farming irrigated, collector-drainage networks, pumping stations, hydrotechnical and other water supplying constructions of the reorganised kolhozes, sovhozes and other agricultural enterprises, taking into account the fact, that their relations are constructed on the basis of an agreement with the other farms.

c) If necessary, to transfer the objects of the social-cultured destination of kolhozes, sovhozes, other agricultural enterprises, reorganised into associations of tenants, co-operatives, dehkan farms, other organisational forms of farming to the balance of the relevant local governmental bodies.

4. To reorganise specialised farms, engaged in the selective, elite-seed-growing and cattle-breeding activities, into state farms (goshozes), irrespectively of their economic state.

5. To order the concern "Madad", the Republican productive association "Tajiknefteproduct" in cooperation to the other interested ministries and agencies to consider and submit during the 2-month period the proposals on the improvement of their services for the kolhozes, goshozes, arenda farms, dehkan farms, husbandries, agricultural co-operatives to the Government of the Republic of Tajikistan.

6. To the Ministry of Finances of the Republic of Tajikistan to forsee allotment of the additional assignments for maintenance of the proper staff number of the created land inspections.

7. To the Ministry of the Agriculture of the Republic of Tajikistan, to the Tajik Academy for agricultural sciences, Ministry of Justice of the RT, Ministry of Finances of the Republic of Tajikistan, to the Committee for Taxation under the Government of the Republic of Tajikistan, to the Agroprombank "SHARK" to organise short-term courses on the study of the current legislation of the Republic of Tajikistan in the fields and which is connected to the land relations and reforms in this sphere, to the creation of dehkan farms by arenda and by organising new forms of farming.
