Amendment of
Second Schedule

1. These Regulations may be cited as Fisheries (Amendment) Regulations, 2020 and shall be read as one with the Fisheries Regulations, hereinafter referred to as "principal Regulations" and shall come into operation on 1st July, 2020.

2. The principal Regulations are amended in the Second Schedule by-
