THE NATIONAL INDUSTRIES REGULATIONS, 2000

Short title 1. These Regulations may be cited as the National Industries Regulations, 2000.

Interpretation 2. In these Regulations, unless the context otherwise requires—
"Act" means the National Industries (Licensing and Registration) Act, 1967;

Act No. 10 of 1967 "Board" means the Board appointed by the Minister under section 10A of the Act;
"prescribe" in relation to forms means prescribed in the Schedule to these Regulations;
"Registrar" means the Registrar of industries:

Application for industrial licence or certificate of registration 3. Every application for an industrial licence shall be submitted through the Board, and in case of application for a certificate of registration to the Registrar or Assistant Registrar.

Application to be on a prescribed Form 1 4. Every application for a first grant or renewal of an industrial licence or a certificate of registration shall be in a prescribed form.

5. Every industrial licence shall be in the prescribed form.	Industrial licence to be in prescribed Form 2
6. Every regulation certificate shall be in the prescribed form.	Registration Certificate to be in prescribed Form 3
7. Every licence shall be authenticated by an official seal.	Licence to be on a seal
8. The project with a fixed investment cost not exceeding one hundred million shillings shall be issued with a certificate of registration and a project with fixed investment exceeding one hundred million shillings shall be issued with an industrial licence.	Project with fixed investment
9. The fee for a certificate of registration shall be US\$ four hundred or its equivalent in Tanzania shillings and the fee for an industrial licence shall be US\$ five hundred or its equivalent in Tanzania shillings.	Registration certificate Fee
10. Where the Registrar—	Registrar to cancel licence
(a) is satisfied that a holder of a licence issued in respect of a project has not, within the period of three years from the date of issue of the licence, implemented that project; and (b) after requiring the person referred to in paragraph (a) to show cause why the licence issued in respect of the project shall not be cancelled, is satisfied that there is no sufficient cause, he may cancel the licence issued in respect of that project and shall report the matter to the Board.	
11.—(1) Every person who holds a valid temporary industrial licence or certificate of registration shall submit, in the case of temporary industrial licence to the Board, and in the case of registration certificate, to the Registrar, a progress report once in every calendar year.	Submission of annual progress report

(2) Every progress report shall be in a prescribed form.

(3) Any person who contravenes the provisions of paragraph (1) of this regulation commits an offence and upon conviction is liable to a fine of fifty thousand shillings payable to the Registrar of Companies.

12. Every application for the transfer of an industrial licence shall be in the prescribed form.

Meeting

13.—(1) The Board shall meet at least four times in a year.

(2) Without prejudice to the generality of subregulation (1) the Chairman may at any time call an emergency meeting.

Appeals
to
Minister

14.—(1) The time within which a person may appeal to the Minister under the provisions of subsection (1) of section 24 of the Act shall be thirty days from the date of the communication of that person of such decision, revocation or variation.

(2) The Minister may for any good or sufficient reason extend the time for the bringing of the appeal.
