(No. 179) B.E. 2540 (1997)

Re: Food in Sealed Container (No. 2)

For export sale promotion of food in sealed containers.

By the virtue of provisions of Section 5 and 6 (1) (2) (4) (5) (6) (7) (9) and (10) of the Food Act B.E. 2522 (1979). The Minister of Public Health hereby issues a notification as follows:

The expression in Clause 11 of the notification of the Ministry of Public Health No. 144 B.E. 2535 (1992), Re: Food in sealed containers dated 2nd July B.E. 2535 (1992), shall be repealed. The following expression shall be used instead:

“Clause 11 This notification shall not to enforce to,

11.1 Food in sealed containers which is produced for export.

11.2 Food in sealed containers conformed to Clause 3 (2) which is exempted by Food and Drug Administration announcement.”

This notification shall come into force as from the day following date of its publication in the Government Gazette.

The Ministry of Public Health has to responsible for consumer protection in which including to the productions, import, and healthcare products sale especially in food export which will bring in foreign currency. The Ministry of Public Health hereby issues its notification (No. 179) B.E. 2540 (1997), Re: Food in Sealed Containers (No. 2), date 12th November B.E. 2540 (1997) as follows:

1. The expression of Clause 11 in the notification of Ministry of Public Health No. 144 B.E. 2535 (1992), Re: Food in Sealed Containers, dated 2nd July B.E. 2535 (1992), shall be repealed.
2. This notification is not to enforce to food in sealed containers produced for export.
3. This notification is not to enforce to food in sealed containers as followed Clause 3 (2) in the notification of the Ministry of Public Health No. 144 B.E. 2535 (1992).
4. This notification of the Ministry of Public Health, which has been published in the Government Gazette: Vol. 114, Part 102 Ngor, dated 23rd December B.E. 2540 (1997), shall come into force on 24th December B.E. 2540 (1997) henceforth.
