MINISTERIAL REGULATIONS

No.2, (B.E.2507)

Issued under the Plant Quarantine Act, B.E. 2507

By virtue of Sections 10,11 and 27 of the Plant Quarantine Act, B.E. 2507, the Minister of Agriculture hereby issues a Ministerial Regulation as follows :

Article 1.- For importation of prohibited materials, the following conditions and stipulations must be complied with :

(1) They must be imported via the following plant quarantine stations :

- a. The Port of Bangkok Plant Quarantine Station.
- b. The Bangkok Airport Plant Quarantine Station.
- c. The Bangkok General Post Office Plant Quarantine Station.

(2) An import tag issued by the Director-General of Department of Agriculture must be attached to the package of prohibited materials.

(3) The prohibited materials must be addressed to the Director-General of Department of Agriculture. If brought in by the owner himself, the prohibited materials must be handed over to the competent official at the plant quarantine station.

Article 2.- When prohibited materials are brought in transit, a transit tag issued by the Director-General of the Department of Agriculture must be attached to the package of the said materials.

Article 3.- For importation or bringing in transit of restricted materials, the owner must, upon their arrival at the plant quarantine station, notify the plant quarantine officer at the plant quarantine station of the same in the declaration form of the Department of Agriculture.

Article 4.- For importation or bringing in transit of unprohibited materials, the owner must notify the plant quarantine officer at the plant quarantine station or customs station of the same in the form annexed to this Ministerial Regulation.

Article 5.- The fees shall be fixed at the rates annexed to this Ministerial Regulation.

Article 6.- The King, Ministries, Dabuangs, Departments, Municipalities and the Thai Red Cross Society shall be exempted from fees under Article 5.

Rates of Fees

Items	Baht
1. Licence to import prohibited materials each	20
Licence to bring in transit prohibited materials each	20
2. Overtime charges payable to the plant quarantine officer working in connection with the importation or bringing in transit of prohibited or restricted materials on official holidays, after official working hours or outside government offices:	
(a) From 6 to 18 hours:	
(1) Plant quarantine officer of the post lower than sectional official or equivalent	
First hour including travelling time, each person	25
Each subsequent hour	10
(2) Plant quarantine officer of the post of sectional official and upwards or equivalent	
First hour including travelling time, each person	50
Each subsequent hour	20
(b) From 18 to 6 hours:	
(1) Plant quarantine officer of the post lower than sectional or equivalent	
First hour including travelling time, each person	30
Each subsequent hour	20
(2) Plant quarantine officer of the post of sectional official and upwards or equivalent	
First hour including travelling time, each person	60
Each subsequent hour	40
