*(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)*

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cynllunio Gwlad a Thref (Coed) 1999 ("Rheoliadau 1999").

Mae rheoliad 2 o Reoliadau 1999 yn gwneud darpariaeth bod rhaid i Orchymyn Cadw Coed fod ar y ffurf a nodir yn yr Atodlen i'r Rheoliadau hynny, neu ar ffurf sydd ag effaith sylweddol debyg.

Mae erthygl 7 o'r ffurf ar Orchymyn Cadw Coed a nodir yn yr Atodlen i Reoliadau 1999 ("y Gorchymyn") yn cymhwyso darpariaethau Deddf Cynllunio Gwlad a Thref 1990, gan gynnwys adrannau 78 a 79 o'r Ddeddf honno, i ganiatadau o dan y Gorchymyn a cheisiadau am ganiatâd o'r fath, yn ddarostyngedig i'r addasiadau a'r newidiadau a grybwyllir yn Rhan 1 o Atodlen 2 i'r Gorchymyn. Mae'r darpariaethau fel y'u haddaswyd a'u newidiwyd yn cael eu nodi yn Rhan 2 o Atodlen 2 i'r Gorchymyn.

Mae'r Rheoliadau hyn yn diwygio darpariaethau yn Rhan 1 ac yn dileu Rhan 2 o Atodlen 2 i'r Gorchymyn.

Effaith y diwygiadau yw ei gwneud yn ofynnol—

- (a) bod hysbysiad apêl yn dod gyda datganiad achos llawn ar ffurf datganiad ysgrifenedig sy'n cynnwys manylion llawn achos yr apelydd a chopïau o ddogfennau ategol; a
- (b) bod yr apelydd yn anfon, cyn gynted ag y bo'n rhesymol ymarferol, gopi o'r hysbysiad apêl a chopi o'r datganiad achos llawn i'r awdurdod a wnaeth y gorchymyn cadw coed.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Town and Country Planning (Trees) Regulations 1999 ("the 1999 Regulations").

Regulation 2 of the 1999 Regulations provides that a Tree Preservation Order must be in the form set out in the Schedule to those Regulations, or in a form substantially to the same effect.

Article 7 of the form of Tree Preservation Order set out in the Schedule to the 1999 Regulations ("the Order") applies provisions of the Town and Country Planning Act 1990, including sections 78 and 79 of that Act, to consents under the Order and applications for such consent, subject to the adaptations and modifications mentioned in Part 1 of Schedule 2 to the Order. The provisions as so adapted and modified are set out in Part 2 of Schedule 2 to the Order.

These Regulations amend provisions in Part 1 and remove Part 2 of Schedule 2 to the Order.

The effect of the amendments is to require—

- (a) a notice of appeal to be accompanied by a full statement of case comprised of a written statement containing full particulars of the appellant's case and copies of supporting documents; and
- (b) the appellant to send a copy of both the notice of appeal and full statement of case to the authority which made the tree preservation order as soon as reasonably practicable.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir i'r Ysgrifennydd Gwladol gan adrannau 199 a 333 o Ddeddf Cynllunio Gwlad a Thref 1990(1), ac sy'n arferadwy bellach ganddynt hwy(2), yn gwneud y Rheoliadau a ganlyn:

The Welsh Ministers, in exercise of the powers conferred on the Secretary of State by sections 199 and 333 of the Town and Country Planning Act 1990(1), and now exercisable by them(2) make the following Regulations:

**Title, commencement, application and interpretation**

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cynllunio Gwlad a Thref (Coed) (Diwygio) (Cymru) 2017 a deuant i rym ar 5 Mai 2017.

1.—(1) The title of these Regulations is the Town and Country Planning (Trees) (Amendment) (Wales) Regulations 2017 and they come into force on 5 May 2017.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(2) These Regulations apply in relation to Wales.

## Amendment to the 1999 Regulations

2.—(1) The 1999 Regulations are amended as follows.

(2) The Schedule (Form of Tree Preservation Order) is amended as follows—

- (a) in article 7, omit paragraph (2);
- (b) in Part 1 of Schedule 2, the adaptations and modifications to section 78(2) of the Planning Act mentioned in column (2) of Part 1 of Schedule 2 are amended as follows—
  - (i) in paragraph (a) after “In subsection (1)” insert “omit paragraph (aa) and”;
  - (ii) after paragraph (c) insert—

“(ca) After subsection (3) insert—  
“(3A) The notice mentioned in subsection (3) must be accompanied by a full statement of case.”;
  - (iii) in paragraph (d) for the substituted subsection (4) substitute—

“(4) The appellant must serve on the authority, as soon as reasonably practicable, a copy of—

    - (a) the notice mentioned in subsection (3); and
    - (b) the full statement of case.”;
  - (iv) after paragraph (d) insert—

“(da) Omit subsections (4A) to (4BB).”;
  - (v) in paragraph (e) in the substituted subsection (5) after “the application of section 79(1)” insert “and section 319B(7)”;
  - (vi) after paragraph (e) insert—

“(f) After subsection (5) insert—

(2) Mae Rheoliadau 1999 yn gymwys i apêl mewn perthynas â'r fath gais neu gyfarwyddyd fel pe na bai'r diwygiadau a wnaed gan reoliad 2(2)(b)(ii), (iii) a (vi) wedi eu gwneud.

- (b) an application for any consent, agreement or approval required by a condition imposed on a grant of consent under such an order, or
- (c) a direction under a tree preservation order or an application for any consent, agreement or approval required by such a direction.

(2) The 1999 Regulations apply to an appeal in relation to such an application or direction as though the amendments made by regulation 2(2)(b)(ii), (iii) and (vi) had not been made.


