**The Animal Health and Welfare (Amendment)  
Regulations (Northern Ireland) 2019**

*Made - - - - 9th April 2019*  
*Coming into operation - 11th April 2019*

The Department of Agriculture, Environment and Rural Affairs<sup>(1)</sup> is designated<sup>(2)</sup> for the purpose of section 2(2) of the European Communities Act 1972<sup>(3)</sup> in relation to common agricultural policy of the European Union and makes these Regulations in exercise of powers conferred by section 2(2) of, and paragraph 1A of Schedule 2 to, that Act.

**PART 1**

**Citation, commencement and interpretation**

**1.** These Regulations may be cited as the Animal Health and Welfare (Amendment) Regulations (Northern Ireland) 2019 and shall come into operation on 11th April 2019.

**2.** The Interpretation Act (Northern Ireland) 1954<sup>(4)</sup> shall apply to these Regulations as it applies to an Act of the Assembly.

2. In regulation 2(1) (interpretation), in the definition of “the Council Regulation”, after “820/97” insert “, as last amended by Council Regulation (EU) No. 653/2014”.
3. In regulation 3(3) (enforcement of the Council Regulation), for “4.5, 4.6” substitute “4.2, 4d”.
4. In regulation 5(1) (powers of an officer of the Department), for “21” substitute “22”.

##### **Amendments to the Cattle Identification (No. 2) Regulations (Northern Ireland) 1998**

5. The Cattle Identification (No. 2) Regulations (Northern Ireland) 1998 are amended as follows.
6. In regulation 2(1) (interpretation)—
  - (a) after the definition of “approved eartag” insert—

““the [Commission Regulation \(EC\) No. 494/98](#)” means [Commission Regulation \(EC\) No 494/98](#) laying down detailed rules for the implementation of Council Regulation (EC) No 820/97 as regards the application of minimum administrative sanctions in the framework of the system for the identification and registration of bovine animals, as amended by [Commission Regulation \(EU\) No 1053/2010](#)”;
7. In regulation 3 (enforcement of Article 4 of the Council Regulation)—
  - (a) in paragraph (1)(a), for “Article 4.5” substitute “Article 4d”; and
  - (b) in paragraphs (3) and (4), for “Article 4.2” substitute “Article 4a”.

8. In regulation 5(1) (movement from a holding), for “the third indent of Article 4.2” substitute “Article 4a.1”.

9. In regulation 6 (replacement eartags), in paragraph (1)(a), for “Article 4.4 or 4.5” substitute “Article 4c.1 or 4d”.

10. In regulation 9 (imports from third countries), in paragraph (1), for “4.3” substitute “4b.2” and omit “(laying down the principles governing the organisation of veterinary checks on animals entering the Community)”.

11. In regulation 10 (transitional provisions relating to eartags), omit paragraphs (1), (2) and (4).

12. In regulation 16 (obstruction), in paragraph (1)(a) and (b), for “Council” substitute “Commission”.

13. In the Cattle Identification (Notification of Births, Deaths and Movements) Regulations (Northern Ireland) 1999, in regulation 2(2) (interpretation)—

### **Amendments to the Cattle Passport Regulations (Northern Ireland) 1999**

““cattle passport” means a document issued by the appropriate competent authority containing the information set out in Article 6.1 of [Commission Regulation \(EC\) No 911/2004](#) (laying down detailed rules for the implementation of Council Regulation (EC) No. 1760/2000 as regards eartags, holding registers and passports in the framework of the system for the identification and registration of bovine animals), as last amended by Council Regulation (EU) No. 653/2014;”;

(b) in the definition of “the Council Regulation”, after “820/97” insert “, as last amended by Council Regulation (EU) No 653/2014”.

16. In regulation 5 (consignment of animals out of Northern Ireland), omit “In accordance with Article 6.3 of the Council Regulation” and after “[Commission Regulation \(EC\) No. 911/2004](#)” insert “(as last amended by Commission Implementing Regulation (EU) No. 2017/949)”.

### **Amendments to the Sheep and Goats (Records, Identification and Movement) Order (Northern Ireland) 2009**

17. The Sheep and Goats (Records, Identification and Movement) Order (Northern Ireland) 2009 is amended as follows.

## **Amendment to the Non-Commercial Movement of Pet Animals Order (Northern Ireland) 2011**

28. The Non-Commercial Movement of Pet Animals Order (Northern Ireland) 2011 is amended as follows.

29. In Article 2(1) (interpretation)—

(a) in the definition of “the Commission Implementing Regulation”, after “of the Council” insert “, as amended by Commission Implementing Regulation (EU) 2016/561”;

(b) for the definition of “the supplementary Regulation” substitute—

““the supplementary Regulation” means Commission Delegated Regulation (EU) 2018/772 supplementing Regulation (EC) No 576/2013 of the European Parliament and of the Council with regard to preventive health measures for the control of *Echinococcus multilocularis* infection in dogs.”

30. In Article 9—

(a) for “7” substitute “6”;

(b) for “2(2)” substitute “7(1)(b)”.

### **Amendment to the Animal By-Products (Enforcement) Regulations (Northern Ireland) 2015**

31. In the Animal By-Products (Enforcement) Regulations (Northern Ireland) 2015, in the Schedule, in the table, in entry 17 (placing on the market and use of organic fertilisers and soil improvers), in the third column, omit “Article 36(1) of the EU Implementing Regulation (transitional measures)”.

### **EXPLANATORY NOTE**

*(This note is not part of the Order)*

These Regulations make minor amendments to miscellaneous legislation relating to animal identification, welfare, disease and trade in animals and animal related products. The Regulations update provisions in that legislation which refer to other domestic or EU legislation that have been amended, replaced or revoked. They also correct some minor errors in legislation that transposes or implements EU obligations.

An impact assessment has not been produced for these Regulations as no impact on the private or voluntary sector is foreseen.
