**Eel Fishing (Licence Duties) Regulations (Northern Ireland)  
2010**

*Made* - - - - - *27th April 2010*

*Coming into operation* - *1st June 2010*

The Department of Culture, Arts and Leisure (**a**) makes the following Regulations in exercise of the powers conferred by sections 15(1) and 19(1) of the Fisheries Act (Northern Ireland) 1966 (**b**) and now vested in it (**c**).

**Citation and commencement**

1. These Regulations may be cited as the Eel Fishing (Licence Duties) Regulations (Northern Ireland) 2010 and shall come into operation on 1st June 2010.

**Licence duties**

2. The licence duties payable to the Department of Culture, Arts and Leisure in respect of licences for the use of fishing engines for the taking of eels specified in column 1 of the Schedule are the amounts specified opposite in column 2 of the Schedule.

**Revocation**

3. The Eel Fishing (Licence Duties) Regulations (Northern Ireland) 2008 (**d**) are revoked.
