EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) 2007 (O.S. 2007/1984 (Cy.165)) i'r perwyl pan fo'r Rheoliadau hynny yn crybwyll "y Rheoliad CE", bydd y cyfeiriad hwnnw yn newidiadwy i raddau penodedig. Bydd unrhyw gyfeiriad o'r fath yn gyfeiriad at Reoliad (EC) Rhif 1925/2006 Senedd Ewrop a'r Cyngor ar ychwanegu fitaminau a mwynau a sylweddau eraill penodol at fwydydd (OJ Rhif L404, 30.12.2006, t.26) fel y caiff y Rheoliad hwnnw ei ddiwygio o bryd i'w gilydd gan newidiadau a wneir i Atodiad I neu II ohono. Mae'r Atodiadau hyn wedi eu diwygio o'r blaen gan Reoliad y Comisiwn (EC) Rhif 1170/2009 (OJ Rhif L314, 1.12.2009, t.36).

These Regulations amend the Addition of Vitamins, Minerals and Other Substances (Wales) Regulations 2007 (S.I. 2007/1984 (W.165)) to the effect that where those Regulations mention "the EC Regulation", that reference will be ambulatory to a specified extent. Any such reference will be to Regulation (EC) No. 1925/2006 of the European Parliament and of the Council on the addition of vitamins and minerals and of certain other substances to foods (OJ No. L404, 30.12.2006, p.26) as that Regulation may be amended from time to time by changes made to its Annexes I or II. These Annexes have been previously amended by Commission Regulation (EC) No. 1170/2009 (OJ No. L314, 1.12.2009, p.36).

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd gan adrannau 16(1)(a), (e) ac (f), 17(2), 26(1)(a) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1), ac a freiniwyd bellach ynddynt hwy(2), fel y darllenir yr adrannau hynny ynghyd â pharagraff 1A o Atodlen 2 i Ddeddf y Cymunedau Ewropeaidd 1972(3).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(a), (e) and (f), 17(2), 26(1)(a) and (3) and 48(1) of the Food Safety Act 1990(1), and now vested in them(2), as read with paragraph 1A of Schedule 2 to the European Communities Act 1972(3).

Yn unol ag adran 48(4A) o Ddeddf Diogelwch Bwyd 1990, mae Gweinidogion Cymru wedi rhoi sylw i gyngor perthnasol gan yr Asiantaeth Safonau Bwyd.

In accordance with section 48(4A) of the Food Safety Act 1990 the Welsh Ministers have had regard to relevant advice given by the Food Standards Agency.

Mae'r Rheoliadau hyn yn gwneud darpariaeth at ddiben a grybwyllir yn adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972 ac mae'n ymddangos i Weinidogion Cymru ei bod yn hwylus i gyfeiriadau at yr offeryn UE a grybwyllir yn rheoliad 3 gael eu dehongli fel cyfeiriadau at yr offeryn hwnnw fel y caiff Atodiadau I a II ohono eu diwygio o bryd i'w gilydd.

These Regulations make provision for a purpose mentioned in section 2(2) of the European Communities Act 1972 and it appears to the Welsh Ministers that it is expedient for references to the EU instrument mentioned in regulation 3 to be construed as references to that instrument as Annexes I and II to it may be amended from time to time.

Enwi a chychwyn

1. Enw'r Rheoliadau hyn yw Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) (Diwygio) 2010 a deuant i rym ar 1 Hydref 2010.

Diwygio Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) 2007

2. Mae Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) 2007(2) wedi eu diwygio yn unol â rheoliad 3.

3. Yn rheoliad 2(1) (dehongli), yn lle'r diffiniad o "y Rheoliad CE" rhodder y diffiniad a ganlyn—

""ystyr "y Rheoliad CE" ("*the EC Regulation*") yw Rheoliad (EC) Rhif 1925/2006 Senedd Ewrop a'r Cyngor ar ychwanegu fitaminau a mwynau a sylweddau eraill penodol at fwydydd, fel y caiff Atodiad I neu II i'r Rheoliad hwnnw ei ddiwygio o bryd i'w gilydd(3);".

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(1), there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

Title and commencement

1. The title of these Regulations is the Addition of Vitamins, Minerals and Other Substances (Wales) (Amendment) Regulations 2010 and they come into force on 1 October 2010.

Amendment to the Addition of Vitamins, Minerals and Other Substances (Wales) Regulations 2007

2. The Addition of Vitamins, Minerals and Other Substances (Wales) Regulations 2007(2) are amended in accordance with regulation 3.

3. In regulation 2(1) (interpretation) for the definition of "the EC Regulation" substitute the following definition—

""the EC Regulation" ("*y Rheoliad CE*") means Regulation (EC) No. 1925/2006 of the European Parliament and of the Council on the addition of vitamins and minerals and of certain other substances to foods, as Annex I or II to that Regulation may be amended from time to time(3);".
