**1 Objective**

The objective of these Regulations is to prescribe the persons who may bring proceedings for offences against a provision of Divisions 4 and 6 of Part 4 of the **Water Industry Act 1994** or regulations made for the purposes of those provisions.

**2 Authorising provisions**

These Regulations are made under sections 179 and 184 of the **Water Industry Act 1994**.

**3 Revocation**

The Water Industry (Melbourne Parks and Waterways - Prescribed Persons) Regulations 1995<sup>1</sup> are **revoked**.

**4 Prescribed persons**

- (1) For the purposes of section 179(1) of the **Water Industry Act 1994** a person who is an authorised officer appointed under section 83 of the **Conservation, Forests and Lands Act 1987** for the purposes of Part 4 and section 184(2) and (3) of the **Water Industry Act 1994** is a prescribed person for the purposes of bringing proceedings for offences against a provision of Part 4 of the **Water Industry Act 1994** or under regulations made under that Part.

- (2) For the purposes of section 179(1) of the **Water Industry Act 1994** a person who is an authorised officer appointed under section 83 of the **Conservation, Forests and Lands Act 1987** for the purposes of Part 4 and section 184(2) and (3) of the **Water Industry Act 1994** is a prescribed person for the purposes of bringing proceedings for an offence against section 78H(1), 78H(2), 78H(3), 78H(4) or 78O of the **Water Industry Act 1994**.

**Note**

Sections 78H and 78O are in Part 3 of the **Water Industry Act 1994**. Part 3 of the **Water Industry Act 1994** is not a relevant law under the **Conservation, Forests and Lands Act 1987**.

### 1. General Information

The Water Industry (Prescribed Persons) Regulations 2003, S.R. No. 21/2003 were made on 24 February 2003 by the Governor in Council under sections 179 and 184 of the **Water Industry Act 1994**, No. 121/1994 and came into operation on 24 February 2003.

The Water Industry (Prescribed Persons) Regulations 2003 will sunset 10 years after the day of making on 24 February 2013 (see section 5 of the **Subordinate Legislation Act 1994**).
