**Surveyors (Fees) Regulations 2003**

**1. Objective**

The objective of these Regulations is to prescribe—

- (a) the fees payable to the Board under the **Surveyors Act 1978**; and
- (b) the allowances payable to members of the Board under that Act; and
- (c) the remuneration of examiners under that Act.

**2. Authorising provision**

These Regulations are made under section 33 of the **Surveyors Act 1978**.

**3. Commencement**

These Regulations come into operation on 17 August 2003.

**4. Revocation**

The Surveyors (Fees) Regulations 1992<sup>1</sup> are **revoked**.

**5. Definition**

In these Regulations "**the Act**" means the **Surveyors Act 1978**.

**6. Fees**

The fees payable to the Board under the Act are the fees listed in Schedule 1.

**7. Examiners' remuneration**

The remuneration payable to an examiner appointed by the Board under section 8(d) of the Act is—

- (a) \$180 for each examination of an assignment;  
and
- (b) \$50 for each examination in professional practice.

**8. Allowances for Board members**

Subject to section 4(8) of the Act, the allowances payable to a member of the Board when travelling in connection with the business of the Board are—

- (a) an allowance for meals, accommodation and other incidentals as set out in Schedule 2;  
and
  - (b) an allowance consisting of—
    - (i) if the member makes the journey in a private vehicle, a travelling allowance as set out in Schedule 2; and
    - (ii) in any other case, the cost of conveyance.

The Surveyors (Fees) Regulations 2003, S.R. No. 99/2003 were made on 14 August 2003 by the Surveyors Board with the approval of the Governor in Council on 12 August 2003 under section 33 of the **Surveyors Act 1978**, No. 9180/1978 and came into operation on 17 August 2003.

The Surveyors (Fees) Regulations 2003 will sunset 10 years after the day of making on 14 August 2013 (see section 5 of the **Subordinate Legislation Act 1994**).
