## NATIONAL FOREST NO. F22, CHIBULUMA EXTENSION

Stating at beacon A on the left side of Kalengwa/Kasempa/Kalulushi road, the boundary proceeds westwards for a distance of approximately 1,000 metres to beacon CE2; thence northwards for a distance of approximately 650 metres to beacon CE3; thence eastwards for a distance of approximately 900 metres to beacon CE4; thence northwards for a distance of approximately 1,450 metres to beacon CE5; thence westwards for a distance of approximately 1,250 metres to beacon CE6; thence northwards for a distance of approximately 800 metres to beacon CE7; thence eastwards for a distance of approximately 1,150 metres to beacon CE8; thence south-westwards for a distance of approximately 1,200 metres to beacon CE9; thence south-westwards for a distance of approximately 1,150 metres to beacon M214; thence north-westwards for a distance of approximately 1,350 metres to beacon CE10; thence north-eastwards for a distance of approximately 1,250 metres to beacon CE11; thence eastwards for a distance of approximately 1,050 metres to beacon CE12; thence south-eastwards for a distance of approximately 1,350 metres to beacon CE 13; thence

north-eastwards for a distance of approximately 1,125 metres to beacon M215; thence southwards for a distance of approximately 3,275 metres to beacon M202; thence eastwards for a distance of approximately 1,400 metres to beacon CE14; thence southwards for a distance of approximately 2,800 metres to beacon CE1, thence generally westwards for a distance of approximately 2,750 metres to beacon A, the point of starting.

The above described area in extent 894 Hectares approximately is shown bordered green on Plan No. NF68 is deposited in the office of the Surveyor-General signed by him dated 19th June, 2006.
