IT is hereby notified that the Minister of Agriculture has, in terms of section 21 of the Fertilizers, Farm Feeds and Remedies Act [Chapter 18:12], made the following regulations:—

#### Title

1.□□These regulations may be cited as the Pesticides Regulations, 2012.

## Interpretation of terms

# 2. In these regulations—

"active ingredient" means the substance in a pesticide which-

- (a) prevents the establishment of, or controls or destroys, plants or insects, or which prevents or cures a disease, infestation or other unhealthy conditions of a plant or a product derived therefrom; or
- (b) stimulates or retards the rate of plant growth;

"appropriate hazardous substances regulations" means—

- (a) in relation to a pesticide which is a group II hazardous substance, the Hazardous Substances and Articles (Group II: General) Regulations, 1981, published in Statutory Instrument 313 of 1981; or
- (b) in relation to any other pesticide, the Hazardous Substances and Articles (Group III: Pesticide) Regulations, 1981, published in Statutory Instrument 318 of 1981:
- "common name" in relation to an active ingredient, means the name accepted by a registering officer as being internationally recognised as the common name of the active ingredient;
- "experimental pesticide" means a chemical to be assessed in Zimbabwe for primary biological activity as a pesticide, and not available to the public as a pesticide;

"pest control operator" means a person who-

- (a) manages the fumigation, hunting, trapping and any other method of eliminating and reducing the occurrence of pests; and
- (b) is registered in terms of section 4 of these regulations:

"pesticide" means a formulation containing an active ingredient, and includes fungicides, biopesticides, pheromones, insecticides, nematicides, acaracides, avicides, herbicides, aboricides, adjuvants, bactericides, molluscicides, rodenticides, termite poisons, any substance which is used for the control of virus disease of plants and any substance which is used to retard or stimulate the growth of plants, wood treatment chemicals, insect and snake repellents, but excludes substances which are intended for plant nutrition or for veterinary remedies and preparations;

"pesticide retailers" means any company registered in terms of section 5 of these regulations to sell pesticides;

"recognised research institution" means a research institution recognised by the Minister as competent to carry out research into pesticide use.

## Registration of pesticides

- 3. (1) No pesticide may be sold unless it is registered in terms of these regulations.
- (2) Every application for registration of a pesticide shall be submitted, in triplicate, to a registering officer in the Form P.1, prescribed in the First Schedule, after government officials have inspected the source of the pesticide.
  - (3) Every application shall be accompanied by—
  - (a) three copies of the text of the label which is intended for use on the container in which the pesticide is to be sold; and
  - (b) two samples of the pesticide, in an amount to be determined by the registering officer, if he or she considers it necessary; and
  - (c) a report from an inspector indicating that he or she has had sight of the manufacturing facility and is satisfied by the production process and the end product; and
  - (d) certificate of analysis local and ex-source; and
  - (e) sworn statement of product content; and

- (f) letter of authorisation of manufacturer or formulator or supplier of the pesticide; and
- (g) evidence of product registration in the country of origin;and
- (h) material safety data sheet, toxicological data, efficacy field trial data, and draft Zimbabwean label.
- (4) An application for the renewal of a registration of a pesticide shall be submitted, in triplicate, to a registering officer in Form P.2, prescribed in the First Schedule, not later than forty-five days before the expiry of registration.
- (5) Every registration of a pesticide and renewal of such registration shall be valid for a period of three years, unless cancelled earlier in terms of the Act:

Provided that the Registrar may if it is in the public interest, approve an application for a shorter period of validity.

- (6) A registering officer shall consider an application for registration or for the renewal of registration in respect of a pesticide manufactured outside Zimbabwe only if the application is submitted through a representative who carries on business in Zimbabwe.
- (7) No application for registration or for renewal of registration shall be considered by a registering officer unless—
  - (a) it complies with the requirements of these regulations; and
  - (b) the applicant furnishes the registering officer with such further information as may be required to determine whether the pesticide is suitable and sufficiently effective for the purpose for which it is intended; and
  - (c) the applicant has a minimum level diploma in agriculture or other relevant qualification recognised by the Ministry of Agriculture in areas covering—
    - (i) safe use of pesticides; and
    - (ii) symptoms of pesticides poisoning and first aid; and
    - (iii) fumigation; and
    - (iv) agriculture and forestry; and

- (v) pest identification and management-entomology, pathology, nematology, crop protection and weed science; and
- (vi) environmental protection; and
- (vii) industrial vegetation and noxious weeds; and
- (viii) wood preservation, including pole treatment; and
  - (ix) fogging and any other relevant skills; and
  - (x) calibration of spraying equipment; and
  - (xi) disposal of empty pesticides containers; and
- (xii) pesticides labelling; and
- (xiii) knowledge of the applicable provisions of the Fertilizers, Farm Feeds and Remedies Act [Chapter 18:12] and the applicable codes of practice for the use of pesticides; and
- (d) the applicant provides medical report duly completed by a registered occupational health practitioner to determine fitness to handle pesticides; and
- (e) the applicant may also be required to submit some well documented evidence of experience in pest control for consideration.
- (8) A registering officer shall, on registering or renewing the registration of a pesticide—
  - (a) issue a certificate of registration or renewal of registration, as the case may be; and
  - (b) forward the certificate to the applicant.
- (9) Registration shall be completed only on receipt by a registering officer of the printed copy of the approved label or a facsimile thereof.
- (10) A registration certificate shall apply only to the pesticide to which the certificate relates.
- (11) No pesticide which has been registered may be altered in any way so as to change its formulation, composition or usage, or in any other manner whatsoever, unless a registering officer so agrees.

- (12) If a registered holder sells his or her company, registration may be transferred to the new owner of the business if—
  - (a) the registration number; and
  - (b) pesticide name; and
  - (c) formulation and name of the company;

remain the same as on the certificate of registration.

- (13) Any person who-
- (a) has acquired a business in terms of subsection (12); and
- (b) decides to change the company name on the certificate;

shall, in writing inform a registering officer of his or her decision and accordingly make an application for registration, together with the payment of the appropriate registration fee.

(14) Any person who has lost a registration certificate shall make an application for replacement of the registration certificate to a registering officer, together with the payment of the appropriate fee.

## Registration of pest control operators

- 4. (1) Any person who wishes to be registered as a pest control operator, shall make an application in writing to a registering officer in the Form P.3, prescribed in the First Schedule.
- (2) A registering officer shall consider an application for registration as a pest control operator only if the application is submitted through a representative who carries on business in Zimbabwe:

Provided that where such registration is approved it shall be valid for no longer than one year.

- (3) An application for the renewal of a registration as a pest control operator shall be submitted not later than thirty days before the expiry of registration.
- (4) A registered pest control operator may have his or her application for renewal of registration denied if, he or she—
  - (a) fails to adequately supervise the use of agricultural remedies; or

- (b) fails to comply with any applicable provision of these regulations; or
- (c) prepares any false or fraudulent record or report; or
- (d) fails to apply pesticides according to label registrations;
   or
- (e) uses banned substances or unregistered products; or
- (f) mixes cocktails of a nature other than the registered and approved mixes; or
- (g) fails to issue notice prior to application of agricultural remedies; or
- (h) fails to keep proper records.
- (4) No application for registration or for renewal of registration as a pest control operator, shall be considered by a registering officer unless the applicant has a minimum level diploma in agriculture or other relevant qualification recognised by the Ministry of Agriculture in areas covering—
  - (i) safe use of pesticides; and
  - (ii) symptoms of pesticides poisoning and first aid; and
  - (iii) fumigation; and
  - (iv) agriculture and forestry; and
  - (v) pest identification and management-entomology, pathology, nematology, crop protection and weed science; and
  - (vi) environmental protection; and
  - (vii) industrial vegetation and noxious weeds; and
  - (viii) wood preservation, including pole treatment; and
  - (ix) fogging and any other relevant skills; and
  - (x) calibration of spraying equipment; and
  - (xi) disposal of empty pesticides containers; and
  - (xii) pesticides labelling; and
  - (xiii) knowledge of the applicable provisions of the Fertilizers, Farm Feeds and Remedies Act [Chapter 18:12] and the applicable codes of practice for the use of pesticides.

- (5) A pest control operator shall—
- (a) ensure that safety measures are in place; and
- (b) notify the public around the facility from which he or she shall embark on any pesticide control operations; prior to embarking on any pest control operations.

# Registration of pesticide retailers and distributors

- 5. (1) Companies registered in terms of the Companies Act [Chapter 24:03] may be registered as pesticide retailer or distributor, if such companies meet the following requirements—
  - (a) they make an application in writing to a registering officer in the Form P.4, prescribed in the First Schedule together with the payment of a prescribed fee; and
  - (b) they operate—
    - (i) away from residential areas and central business districts;
    - (ii) away from humans livestock and the environment so as to not pose a danger to them;

and

- they employ persons with agricultural qualifications from recognised colleges or diplomas in handling pesticides from accredited bodies; and
- (d) they ensure that their outlets have the following—
  - (i) concrete floors; and
  - (ii) good ventilation; and
  - (iii) septic tanks; and
  - (iv) fire extinguishers; and
  - (v) lockers for highly hazardous substances; and
  - (vi) showers; and
  - (vii) saw dust or sand; and
  - (viii) drains; and
    - (ix) lockers for pesticide handlers personal protective equipment;

and

(c) they sell locally registered pesticides in Zimbabwean labels only, that are clean and appropriate; and

- (f) they provide evidence of support from a registered importer and distributor of pesticides; and
- (g) they pay the prescribed registration fee as set out in the Third Schedule.
- (2) No application for registration or for renewal of registration as a pesticides retailer or distributor, shall be considered by a registering officer unless the applicant has a minimum level diploma in agriculture or other relevant qualification recognised by the Ministry of Agriculture in areas covering—
  - (i) safe use of pesticides; and
  - (ii) symptoms of pesticides poisoning and first aid; and
  - (iii) fumigation; and
  - (iv) agriculture and forestry; and
  - (v) pest identification and management-entomology, pathology, nematology, crop protection and weed science; and
  - (vi) environmental protection; and
  - (vii) industrial vegetation and noxious weeds; and
  - (viii) wood preservation, including pole treatment; and
    - (ix) fogging and any other relevant skills; and
    - (x) calibration of spraying equipment; and
    - (xi) disposal of empty pesticides containers; and
  - (xii) pesticides labelling; and
  - (xiii) knowledge of the applicable provisions of the Fertilizers, Farm Feeds and Remedies Act [Chapter 18:12] and the applicable codes of practice for the use of pesticides.

#### **Conditions**

- 6. (1) A registering officer, on registering a pesticide, may, on the registration certificate, impose such conditions as he or she thinks fit.
- (2) Notwithstanding the generality of subsection (1), it shall be a requirement that any pest control operator, pesticide retailer and pesticide importer, who has been successful in his or her application for a registration certificate shall submit quarterly returns to the Pesticides Registration Office.

#### Experimentation

- 7. (1) No person shall import into Zimbabwe any experimental pesticide unless he or she is authorised, in writing, by a registering officer to do so.
- (2) Any person who imports an experimental pesticide shall, not later than seven days after the arrival of the pesticide in Zimbabwe, complete, in triplicate, and forward to a registering officer Form P.5, prescribed in the First Schedule:

Provided that, where an experimental pesticide is imported by a recognised research institution, it shall, if a registering officer so permits be sufficient for the recognised research institution to supply the registering officer with the name or designation only of the experimental pesticide.

- (3) No experimental pesticide shall be offered to any person other than a person approved by a registering officer to participate in the experimentation.
- (4) In granting permission to import an experimental pesticide in terms of subsection (1), a registering officer may impose such conditions as he or she deems necessary with regard to the experimentation with the pesticide.
- (5) It shall be a condition for the importation of experimental pesticides that plants treated with experimental pesticides shall not be sold or disposed of for consumption without the written authority of a registering officer.
- (6) The label affixed to a container in which a pesticide is imported for purposes other than sale shall be clearly marked or printed with the words "FOR EXPERIMENTAL PURPOSES ONLY -NOT FOR SALE".

# Import of pesticides

8. (1) Any person who wishes to import into Zimbabwe any pesticides may apply for a permit to do so, if such person's core business is the buying and selling of pesticides:

Provided that the pesticides are locally registered and bear the company name, registration number, pesticide name and formulation,

source of pesticide, amount paid for pesticides, and receipt number and expiry date for pesticides.

(2) An application for an import of pesticides permit shall be made in writing to a registering officer in the Form P.5, prescribed in the First Schedule together with the payment of a prescribed fee:

Provided that import of pesticides permit shall be valid-

- (i) for sixty days from the date of issue if the source is within the SADC region; and
- (ii) for ninety days from the date of issue if the source is outside the SADC region and Africa; and
- (iii) for one consignment only and in terms of the source specified in the registration certificate.
- (3) Any person who wishes to import any pesticides, in terms of subsection (1), shall—
  - (a) ensure that an extra 100 ml is available as part of the consignment, for the purpose of random sampling and analysis by inspectors; and
  - (b) ensure that the products bear Zimbabwean labels; and
  - (c) have a valid registration certificate.
- (4) Any person who imports pesticides without having a permit shall be responsible for any costs incurred at ports of entry or exit and any other cost that may result from the illegal importation of goods.

# Export of pesticides

9. (1) Any person who wishes to export any pesticides out of Zimbabwe may apply for a permit to do so:

Provided that the pesticides, are locally registered and bear the company name, registration number, pesticide name and formulation, source of pesticide, amount paid for pesticides and receipt number and expiry date for pesticides.

(2) An application for an export of pesticides permit shall be made in writing to a registering officer in the Form P.5, prescribed in the First Schedule together with the payment of a prescribed fee:

Provided that export of pesticides permit shall be valid thirty days from the date of issue per consignment.

(3) Any person who wishes to export any pesticides, in terms of subsection (1), shall ensure that the products bear Zimbabwean labels.

## Appeals

- 10. An applicant who wishes to appeal against a decision of a registering officer in terms of section 7 of the Act shall—
  - (a) request the registering officer, in writing, for his or her reasons for refusing the application, imposing conditions or cancelling the registration, as the case may be, and the registering officer shall, within fourteen days of the receipt of the request, furnish the applicant, in writing, with his or her reasons; and
  - (b) within fifty-six days of being notified of the refusal, imposition of conditions or cancellation, as the case may be, appeal, in writing, against the decision of the registering officer to the Minister.

# Approval of brands

11. (1) Subject to the provisions of subsection (2), a registering officer shall, before registering any brand, consult the Registrar of Trade Marks, and satisfy himself or herself that the name of the brand does not resemble the name of any other brand of any nature whatsoever:

Provided that, in the event at a later stage it is discovered that the brand name is a name that has been registered elsewhere, the applicant shall be responsible for any claims arising as a result of the use of that brand name.

- (2) A pesticide shall not be registered under a brand if, in the opinion of a registering officer, the brand is—
  - (a) of an insufficiently distinctive nature; or
  - (b) so similar to a brand under which a pesticide has already been registered as to be liable to be mistaken for the other brand.

#### Labelling

12. (1) No person shall sell any pesticide unless the label is securely affixed to the container, and clearly and indelibly marked in English or any other indigenous language recognised in Zimbabwe and, where a registering officer considers appropriate, in an indigenous language:

Provided that, if an indigenous language is used, an accurate translation shall be lodged at the time of registration with the registering officer.

- (2) The label, which shall be identical in all respects to that approved by a registering officer in terms of section 3, shall state—
  - (a) the company brand or symbol; and
  - (b) the brand name of the pesticide; and
  - (c) the registration number which the pesticide is registered; and
  - (d) the net quantity by mass or volume in the container; and
  - (e) the purposes for which the pesticide has been registered; and
  - (f) the directions for use of the pesticide; and
  - (g) such information as is prescribed in the appropriate hazardous substances regulations; and
  - (h) any other information which a registering officer may approve or consider to be necessary.
- (3) Pesticides transported within the borders of Zimbabwe to premises where they are further processed, packed or repacked for the retail trade shall be clearly and indelibly marked with the particulars prescribed in paragraphs (a), (b), (c), (d), (g) and (h) of subsection (2).
- (4) An equilateral triangle shall be printed on, or securely affixed to, the main panel of the label in a colour approved by a registering officer, which triangle shall occupy an area of not less than five per centum of the area of the label.
- (5) The triangle referred to in subsection (4) shall be coloured purple, red, amber or green—

- (a) as specified in the appropriate hazardous substances regulations; or
- (b) as approved by the Hazardous Substances and Articles Control Board, in terms of those regulations.
- (6) The triangle of approved colour shall be located on the label in a position directly below the brand name of the pesticide, and the composition and registered number of the pesticide, and the net mass or volume of the container shall appear directly above or below the triangle, which shall be delineated from the rest of the label by a black border or a black border on white background to emphasize the approved colour.
- (7) No detail other than the composition and registered number of the pesticide and the net mass or volume of the container shall appear in a position between the brand name of the pesticide and the triangle approved colour.
- (8) Except with the permission of a registering officer, no label shall contain any information or matter other than that provided for in this section.
- (9) No label, once it has been approved by the registering officer, shall be altered in any manner whatsoever without the written approval of the registering officer, unless the alteration is made at the direction of the Hazardous Substances and Articles Control Board, and the registering officer has been notified that it is to be made.

#### Containers

- 13. (1) No pesticide may be sold, transported or stored unless a registering officer is satisfied that the container in which the pesticide is to be packed is of sufficiently durable construction and material.
- (2) A container which contains any combustible substance shall be of metal, glass or other non-combustible material.
- (3) Pesticides which contain toxic or inflammable volatile ingredients shall be packed in durable, airtight containers.
- (4) All liquid pesticides shall be packaged in white fluorinated high density polythene, brown glass bottles or any other form of packaging approved by the Pesticide Registering Office.

#### Guarantee

Ç

14. Any representation or claim on a label concerning the chemical composition or the chemical and physical properties of a pesticide shall constitute a guarantee by the applicant of that pesticide for its chemical composition and its chemical and physical properties within the limits of five *per centum* variation of the stated figure.

#### Advertisements

- 15. No person shall, in an advertisement of a pesticide—
  - (a) state, imply or infer that the Government has guaranteed or approved the efficacy of the pesticide:

Provided that nothing shall prohibit the use, in an advertisement, of the words "Registered in terms of the Fertilizers, Farm Feeds and Remedies Act [Chapter 18:12];

(b) make or insinuate any claim in respect of such pesticide, other than a claim approved by a registering officer:

Provided that any person who wishes to advertise a pesticide shall do so after the Pesticides Registration Office has approved a draft advert.

# Use of pesticides

- 16. (1) Pesticides shall not be used for any purpose other than the purpose for which they are registered.
- (2) Registered companies with the appropriate skilled labour, equipment and premises may repackage pesticides.

# Fees and fines

17. Fees and fines shall be charged as set out in the Second Schedule.

# Offences and penalties

- 18. Any person who-
  - (a) sells unlabelled pesticides or wrongly labelled pesticides;
     or
  - (b) sells pesticides illegally without being registered in terms of these regulations; or

- (c) illegally imports or exports pesticides; or
- (d) illegally makes use of a trade name that he or she is not registered under; or
- (e) illegally repackages pesticides; or
- (f) illegally discharges pest control services; or
- (g) contravenes any provisions of these regulations;

shall be guilty of an offence and liable to a fine not exceeding level four or a fine as prescribed in the Third Schedule, in default of such payment, to imprisonment for a period not exceeding three months or to both such fine and such imprisonment.

## Repeals

19. The regulations specified in the Third Schedule are repealed.
